The three-storey business centre provides flexible serviced office accommodation for start-up and small businesses offering from two person offices upwards, in a contemporary business environment.

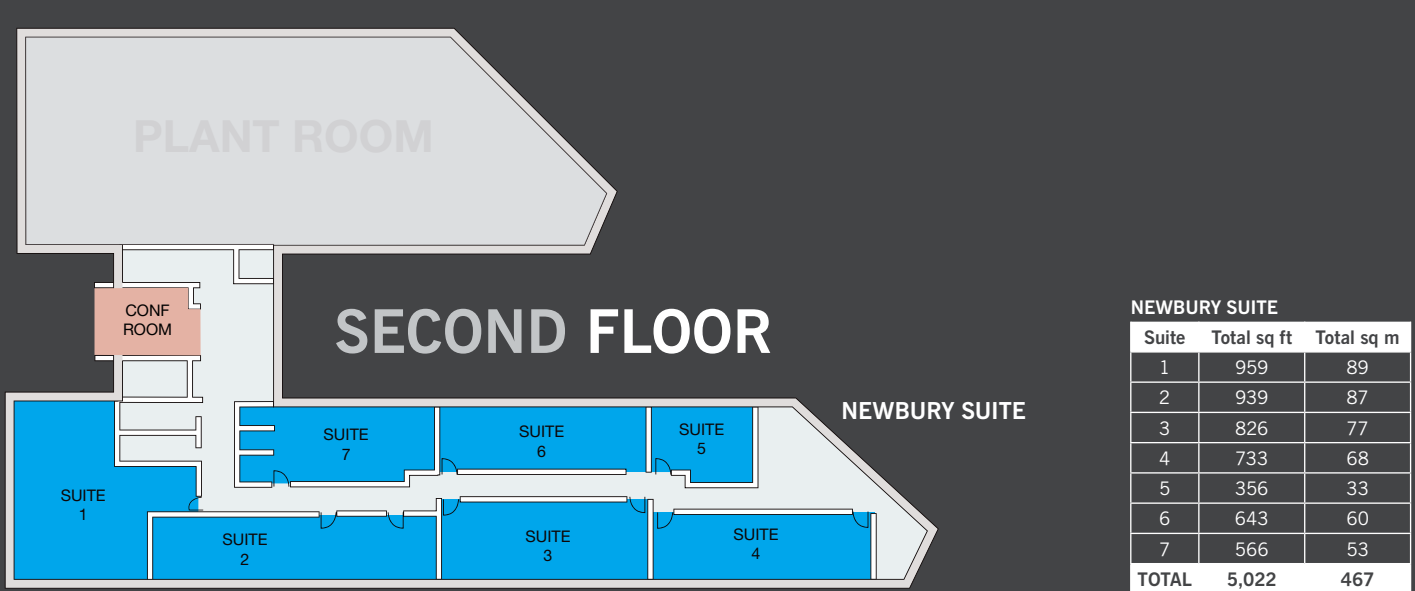
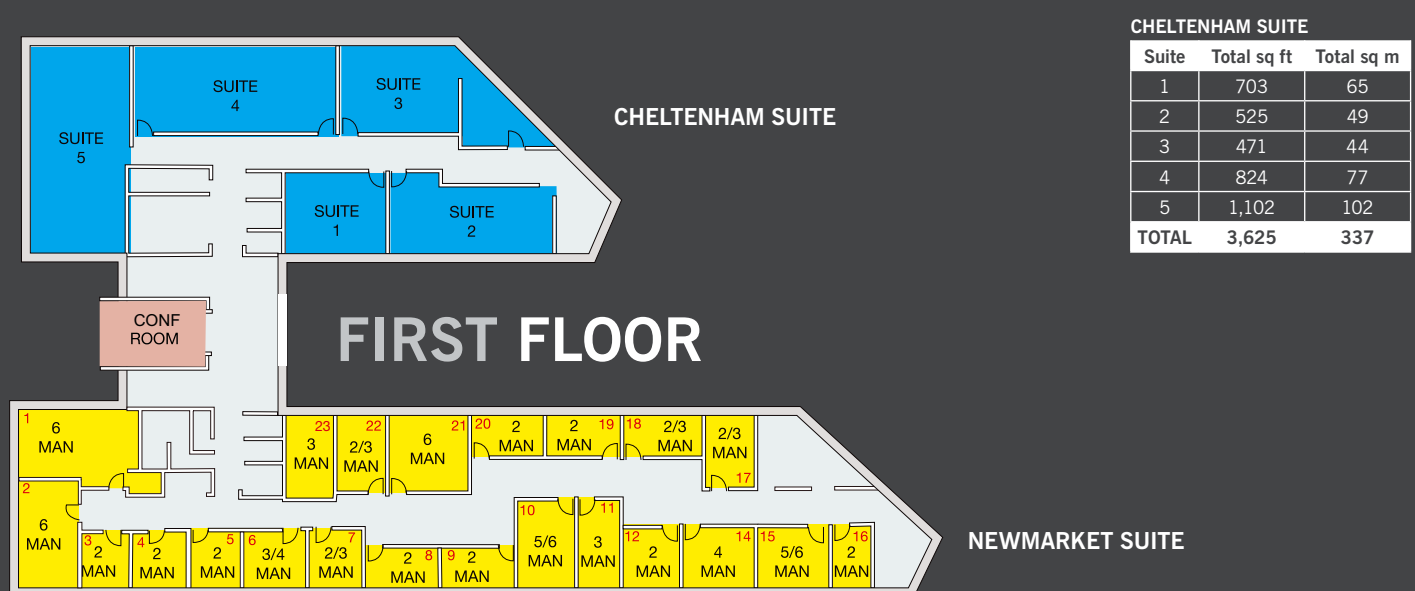
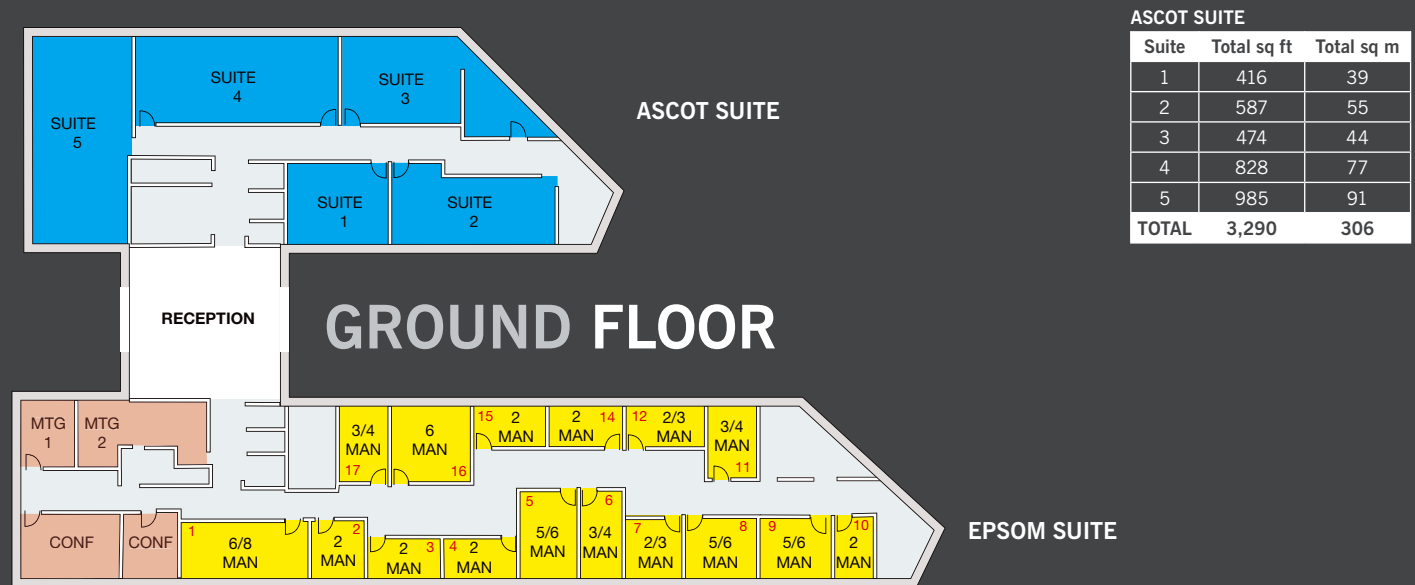

## KEYS BUSINESS VILLAGE LAYOUT



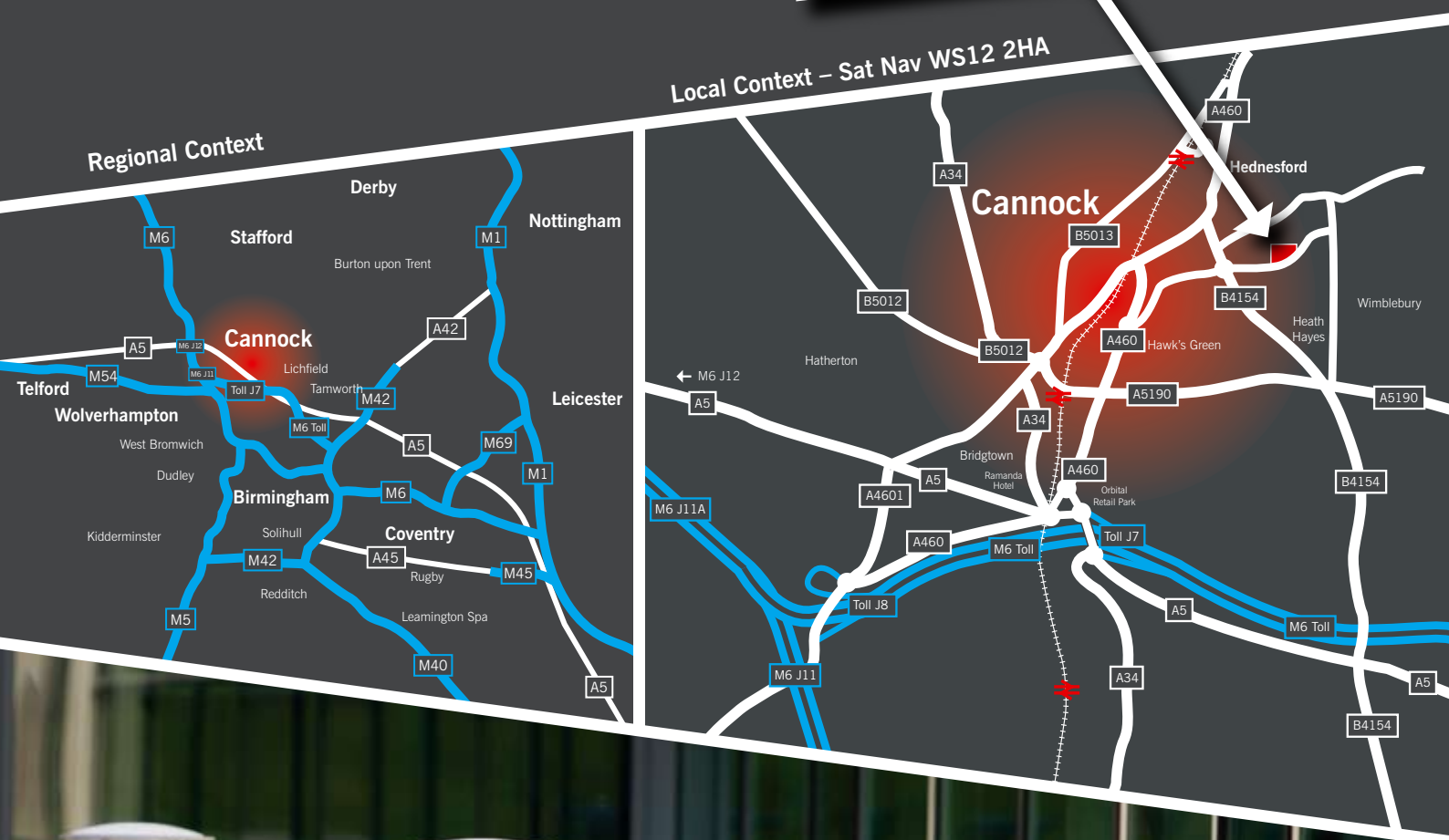
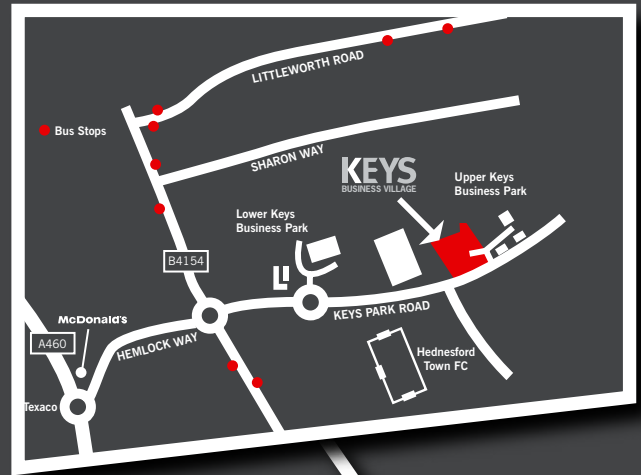
